Hello,

This is a content removal request regarding publications on the website <https://ednakarnaval.com/>, which is stored within your servers.

I am addressing you on behalf of the Cybercrime Department in the Israeli State Attorney's Office. Within the duties of the department, we deal with illegal content published online, on websites, on social media, etc.

It has got to our attention that the website mentioned above has been publishing articles containing content that violates the Israeli law. Moreover, we believe these publications violate StackPath's terms of use as we understand it, regarding the use of your servers in order to publish harmful or illegal content:

Article 1. Policy -

"Do not use StackPath in any jurisdiction for unlawful, obscene, offensive or fraudulent content or activity, such as advocating or causing harm...or violating third party rights."

On top of that:

"Do not use StackPath Services to...distribute harmful or destructive programs or content...engage in any other abusive or illegal activities

Hereby we would like to mention few examples which indicate the violations mentioned above:

1. The following URL contains content which violates Article 2(5) of the Israeli Privacy Protection Law (1981), such as private information in the form of email addresses, phone numbers, home addresses, I.D numbers, concerning public figures in Israel including judges and other seniors serving in the judiciary.

3. The article in the following URL publishes transcripts under a specific non publication order (attached). The transcripts are a part of a criminal case in which a young woman in Israel survived her husband's brutal attempt to murder her in front of their minor child.
