**To the Competent Authorities of the Italian Republic:**

**REQUEST FOR ASSISTANCE IN A CRIMINAL MATTER**

1. In accordance with the European Convention on Mutual Assistance in Criminal Matters, the State of Israel hereby requests that the Italian Republic grant legal assistance and execute Letters Rogatory in the manner provided for by the laws of the Italian Republic. This assistance relates to an on-going investigation conducted by the Israel Police into criminal offences of Breaking and Entering into a Building, Theft Under Special Circumstances and Possession of Suspect Property, the details of which are set forth below.
2. The Request is signed and submitted by the Director of the Department of International Affairs who is authorized to submit such requests on behalf of the State of Israel.

**Factual Background**

3. On November 11, 2014, Isaac Lane (hereinafter: "**Lane**") submitted a complaint with the Israel Police, that 22 luxury watches were stolen from his home in Hertzelia, Israel.

4. On February 10, 2022, Lane contacted the Israel Police, and informed the investigators, that through a post on a website, that sells luxury watches (Chromo 24), he located one of his stolen watches.
5. The watch was listed under the heading "Audermars Piguet Royal Oak Chronograph 'Dubail' 25983SP mai indossato", and listed for sale for 99,471\$.  
  
A copy of the posting is attached to this request and marked **Attachment A**.
6. According to Lane, he contacted the seller of the watch, located in Rome, Italy, and confirmed that it is indeed his stolen watch, since it had a specific number engraved on it (25), and it also had the same serial number. After confirming that, he submitted a complaint with the Italian Police.
7. According to information provided by the Italian Police to the Israel Police, the seller was contacted and the watch was seized.
8. The Israel police are conducting an ongoing criminal investigation into the suspected criminal offenses of Breaking and Entering into a Building, Theft Under Special Circumstances and Possession of Suspect Property, allegedly committed by the seller of the watch.

#### **Purpose of this Request**

9. The purpose of the request is to receive the assistance of the Italian authorities in returning the watch to Israel and questioning the suspect.

#### **Details of the Assistance Requested**

10. The Italian authorities are kindly requested to transfer the watch to the Israel Police, with the intention of returning the watch to its original owner.
11. According to the Israel Police, the watch which is evidence, related to the abovementioned investigation, may be found by Prosecutor's Office in Rome, according to the following information:

12. The Italian authorities are requested to provide the Israeli authorities with the watch.

13. In addition, the Italian authorities are requested to locate and question the seller of the watch as a suspect. A list of questions is attached to this request and marked **Attachment B**.

14. In order for his statement to be admissible in an Israeli Court, in accordance with Israeli law, the suspect should be warned and advised of his right against self-incrimination, as follows:

"I, (name, rank and ID no.) hereby wish to inform you that you are suspected of Breaking and Entering into a Building, Theft Under Special Circumstances and Possession of Suspect Property. You have the right to remain silent; however, refusal to answer questions can strengthen the weight of evidence against you in an Israeli court. Anything you say will be written by me and may be used against you in an Israeli court. You have the right to consult with an attorney".

15. The Italian authorities are kindly requested to provide any further assistance that may be required in this matter, in accordance with the developments in the investigation in this matter.

### **Time Constraints**

16. The authorities of Italy are kindly requested to consider this Request at the earliest convenience.

## **The Relevant Statutory Provisions of Israeli Law**

17. Article 384A(b) of the Israeli Penal Law, 5737-1977 (hereinafter: "**the Penal Law**") provides that:

### ***Theft under special circumstances***

*384A(b) A person who commits theft a thing that is worth more than 500,000 NIS is liable to seven years imprisonment.*

18. Article 405 of the Penal Law provides that:

### ***Breaking, entering and housebreaking***

*405. (a) If a person breaks any external or internal part of a building, or if he opens – with a key, by pulling, pushing, lifting or in any other manner – a door, window, shutter or anything intended to close or cover an opening in a building or an opening that permits passage from one part of a building to another, then he commits breaking.*

*(b) If a person introduces any part of his body or of an instrument used by him into a building, then he commits entering.*

*(c) If a person breaks and enters or breaks and exits, then he commits housebreaking.*

*(d) If a person enters a building by a threat, by artifice or in collusion with a person in the building, or if he enters a chimney or other aperture of a building permanently left open for a particular purpose but ordinarily is not intended to be used for entry, then he is deemed to have broken and entered.*

19. Article 413 of the Penal Law provides that:

### ***Possession of suspect property***

*413. If a person has possession of a thing, of money, a security or another asset, in respect of which there is a reasonable suspicion that it was stolen, and if he is*

*not able to establish to the Court's satisfaction that he acquired possession of it lawfully, then he is liable to six months imprisonment.*

**Supplementary**

20. The State of Israel will submit any additional information which the Italian Republic may require in order to enable them to accede to this request.

1. Did you ever visit Israel?
2. If so, where did you stay during your visit(s) to Israel?
3. How long did you stay in Israel?
4. Where did you get the watch in question?
5. Did you get any additional watches from the same source?
6. Did you receive the watch with original ownership papers?
7. The watch in question is very unique and expensive, it's details are listed with the manufacturer of the watch and it is listed there as a stolen watch. Did you not check with the manufacturer when you received the watch?
