## **Consulting and Cooperation Agreement**

### **General**

**Elsmed Healthcare Solutions Ltd.** and **Ergo (E.B. 2014) Ltd.** (Hereinafter "The Parties") consider establishing wide cooperation and consulting relationships between the two companies in order to promote and develop **Elsmed Healthcare Solutions Ltd.** (hereinafter "**Elsmed**") businesses. As a first step towards this mutually agreed objective the two Parties agreed upon the following:

### **Content of Cooperation**

**Elsmed** is interested, as a part of its business development plans, to participate in the design, equipment procurement, staff training and operation of a state of the art hospital project in **Chimkent, Kazakhstan** (hereinafter "the Project").

**Ergo Ltd.** Will consult **Elsmed Ltd.** on this project and the two Parties will cooperate as needed and in good faith in order to achieve the above mentioned results.

This agreement is limited to this Project. Any further project in the future, namely, other than **Chimkent Hospital** will be agreed and signed separately.

### **Terms of the Agreement**

The term of this agreement is for three years (3 yrs) or the date of actual full activation of the Project -whatever comes later.

This agreement may be terminated at any time by either Party with three months advance written notice to the other Party. In case of an early termination

all rights for any fees or compensation earned according to the Agreement by the date of actual termination will remain in force and will be dealt with accordingly by the Parties in the period following the termination. to remove any doubt, it is agreed that in the case of Operating Agreement being signed between the Project and **Elsmed Ltd.** following the introduction made by **Ergo Ltd.** then **Ergo Ltd.** will have the right for its compensation and **Elsmed Ltd.** will pay the amounts as detailed in Compensation paragraph hereunder, even if actual signing of the Operating Contract occurred after termination entered into power.

### **Compensation**

In case of a success, namely if **Elsmed** or a Company under its full or partial control, or the full or partial control of anyone of its Principals will win a contract to all or part of the Project and/or its operation, the Parties agreed on the following:

**Ergo Ltd.** will have the right for and **Elsmed Healthcare Solutions Ltd.** will transfer to **Ergo Ltd.** the Success Fee of seven and half percent (7.5%) of any

amount/compensation actually received from this contract to **Elsmed**'s bank account /ownership.

If beyond design, construction, training, and/or equipment procurement, an Operating Contract or PPP Contract will also be won by **Elsmed Ltd.** in regard to the Project of **Chimkent Hospital**, then **Ergo Ltd.** will have the right and **Elsmed Ltd.** will transfer to Ergo Ltd. ten percent (10%) of any payment or compensation which **Elsmed Ltd.** or another entity under Elsmed Ltd. control or partial ownership, or any entity held fully or partially by an Elsmed Ltd. Principal- actually received from this contract to **Elsmed Ltd.**'s bank account/ownership.

#### Expenses

All expenses will be carried by each Party independently.

#### Non conflict, Non exclusive

**Ergo Ltd.** and **Elsmed Healthcare Solutions Ltd.** will make sure that other activities taken by the respective Parties and their Principals will not create conflict of interest regarding its commitments to the other Party, as reflected in this agreement.

This Agreement does not provide exclusivity on/by either side.

#### Governing Law and Jurisdiction

This agreement shall be governed by and construed in accordance with the laws of the State of Israel.
