4. דריש צו לגולל לצורך איסור לוגים אשר יובילו לזהות פותח תיבת המייל של גוגל נשואת הצו.

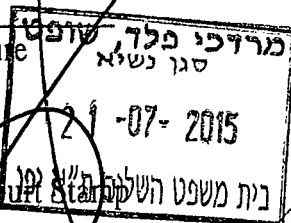

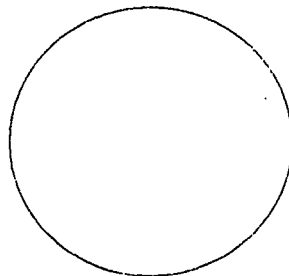
